Class Policies

- Grades will be based on the following criteria: 40% Exams, 15% Class Participation, 35% Quizzes, 10% Local Government Meeting Attendance & Report.
- Exams will be handed out in class in a sealed envelope. (If a student is not in class when exams are handed out, a parent will need to request a copy of the exam and the instructor will email a copy of the exam to the parent.) Students should not break the seal until they are ready to take the exam and a parent is available to proctor. To protect the integrity of the exam, students need to return exams to the instructor in an envelope sealed under a parent signature. All other assignments are open book and do not require an envelope, signature, or proctoring.
- Quizzes will be handed out in class approximately two weeks ahead of their due date so students may work ahead if they wish or if they know they will be out of town. Quizzes can also be requested via email. It is recommended that students take the quizzes while reading through the chapter. All quizzes are open book.
- Class will begin promptly at Noon. Please be in your seat ready to begin by 11:59 AM. If you are unavoidably late, please enter class as unobtrusively as possible.
- All assignments are to be turned in during class by the due date in class unless otherwise specified. I really appreciate students using staples to keep their multi-page assignments together. If the student is not in class that day, please email the instructor a scanned copy of the assignment by Noon the day the assignment is due. Graded tests and quizzes will be returned the following week.
- Unless a parent emails the instructor in advance to make alternative arrangements, late assignments will be accessed a 10% penalty per day. Assignments more than 3 days late will be given a 0%.
